INDEMNIFICATION AND HOLD HARMLESS AGREEMENT

Now comes the undersigned being (name/s) _____,
(hereinafter the "Undersigned,") and the Board of Township Trustees of Jefferson Township, Franklin
County, Ohio, (hereinafter the "Township") and enter into this Agreement on this _____ day of

WHEREAS, The Undersigned desires to rent a garden plot or two garden plots for the purpose of
growing flowers, vegetables, herbs, etc. (no illegal or noxious plants may be grown), and

WHEREAS, the Township agrees to permit the activity described in the preceding paragraph,

NOW, THEREFORE, the Undersigned and the Township, in consideration of the mutual covenants
and agreements, hereby agrees as follows:

The Undersigned agrees to indemnify and hold harmless the Township and each member of the Board
of Trustees of the Township and each officer of said Board (and their heirs, executors, administrators
and assigns) who is made a party or is threatened to be made a party to any litigation, action, suit or
proceeding, whether civil, criminal, administrative or investigative by reason of the fact that he is or
was a trustee, officer, employee or agent of the Board or is or was serving at the request of the Board
against expenses, attorney's fees, judgments, fines and amounts paid in settlement actually and
reasonably incurred by him in connection with such action, suit or proceeding in connection with any
activity by the Undersigned, or his designee, employee, agent, assign or contractor permitted under this
agreement including, but not limited to, any negligent or intentional act which results in any harm or
damage to another or to property of another. The foregoing right of indemnification shall not be
exclusive of other rights or remedies to which such Board or Township official, or their heirs,
executors and administrators may be entitled.
